Privacy Policy

Purpose

Data Collected Automatically

When you visit and use our Site, we may automatically collect and store the following information:

- 1. IP address; and
- 2. Location.

Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

- 1. First name;
- 2. Last name;
- 3. Email address
- 4. Phone number.

This data may be collected during the account creation process.

How We Use Personal Data

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for administration and internal uses.

The data we collect when the user performs certain functions may be used for account generation and communication.

Who We Share Personal Data With

Employees

We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

Third Parties

We may share user data with the Stripe for payment processing purposes. We may share the following user data with Stripe:

1. First name;

- 2. Last name;
- 3. Email address.

Third parties will not be able to access user data beyond what is reasonably necessary to achieve the given purpose.

Other Disclosures

We will not sell or share your data with other third parties, except in the following cases:

- 1. If the law requires it;
- 2. If it is required for any legal proceeding;
- 3. To prove or protect our legal rights; and
- 4. To buyers or potential buyers of this company in the event that we seek to sell the company.

How Long We Store Personal Data

How We Protect Your Personal Data

In order to protect your security, we use the strongest available browser encryption and store all of our data on servers in secure facilities.

While we take all reasonable precautions to ensure that user data is secure and that users are protected, there always remains the risk of harm. The Internet as a whole can be insecure at times and therefore, we are unable to guarantee the security of user data beyond what is reasonably practical.

International Data Transfers

We transfer user personal data to the following countries:

- 1. Canada;

Children

We do not knowingly collect or use personal data from children under 13 years of age.
